THE IMPORTANCE OF THE EUROPEAN UNION FOR AMERICANS

The European Union has a membership of 25 states, including all the major states of Europe west of Russia. It is the world's largest economy as measured by gross domestic product, it is the world's largest external trader, it has a market size of 450 million people, and it has a currency - the euro - that is rapidly establishing itself as the world's second most important currency. Europe, and within Europe the EU, is the US's most important political ally. This means that it is crucially important to understand Europe's attempts to develop common positions on foreign and defense questions, all the more so when US politicians and spokesmen call on Europe to make a fuller contribution to international security.

THE PROGRAM DIRECTORS: The program of activities will be led and coordinated by:



Neill Nugent (M.A. University of Kent), Professor of Politics & Jean Monnet Professor of European Integration at Manchester Metropolitan University, United Kingdom. An internationally-recognized scholar, Professor Nugent has published widely on the European Union and European politics. His books include *European Union Enlargement* (editor), Palgrave-Macmillan, 2004; *The Government and Politics of the European Union*, Duke University Press, 5th edition, 2003; *The European Commission*, Palgrave-Macmillan, 2001; *At the Heart of the Union: Studies of the European Commission* (editor), St Martin's Press, 2nd edition, 2000; *Developments in*

the European Union (co-editor) Macmillan, 1999; The European Union. Volume I and II: Perspectives and Theoretical Interpretations (editor), Dartmouth, 1997; The European Business Environment (co-editor), Macmillan, 1994. He was the editor of The European Community: Annual Review of Activities from 1992-1996. He has organized simulations for students and civil servants in Britain, the Netherlands, the Czech Republic, Bulgaria, and New York. Professor Nugent was an EU Fulbright Scholar (2003) at SUNY Fredonia and a University of Michigan's EU Center Visiting Scholar in 2002. He has also taught the EU at Duke University and the University of South Dakota. He has delivered invited lectures throughout Europe and the United States. He has conducted training seminars for: European diplomats from South East Europe - for the College of Europe and the American University in Bulgaria, Blogoevegrad, Bulgaria; French public administrators - as part of the EU's INTERREG IIB North West Programme in Lille, France; civil servants in Serbia-Montenegro, Belgrade - for the College of Europe and the Government of Serbia-Montenegro; for civil servants in Poland, Warsaw - for the College of Europe and the Government of Poland; and Greek diplomats - at the Spetses Greek Foreign Service Summer Academy. He serves as a consultant and advisor to various external agencies on a number of academic-related matters such as assessor of degree programmes, contributor to television and radio programmes, and talks to community groups, including business associations. Professor Nugent is European director for the Transatlantic Consortium for European Union Studies and Simulations and Academic Director for the Institute for European Union Studies at SUNY, Visiting Professor at the College of Europe in Bruges and at the Centre for European Integration at the University of Bonn.



Laurie Buonanno (Ph.D. The Johns Hopkins University), Associate Professor, Department of Political Science, State University of New York, Fredonia specializes in the study of European identity and policy making in the European Union. Dr. Buonanno is Executive Director of the Institute for European Union Studies at SUNY. She recently completed a six-year term as director of the Transatlantic Consortium for European Union Studies and Simulations (TACEUSS) and continues to serve as a faculty advisor to TACEUSS's Model European Union

(EuroSim). Dr. Buonanno has authored many grants - including to the European Union - to support curriculum development, educational outreach, and student and faculty scholarship in European Union studies. She has delivered lectures on EU food safety, European identity, and transatlantic relations in several European countries and the United States. Dr. Buonanno has delivered papers and published articles and book chapters on EU food safety policy, European identity, on-line teaching of the EU, and EU simulation organization and assessment. She is currently co-authoring (with N. Nugent) *Policies and Policy Making in the European Union* (Palgrave) and co-editing (with J. Mather) *The Future of Europe*. Dr. Buonanno received the State University of New York's Chancellor's Award for Excellence in Teaching in 1995.

Alan Cafruny (Ph.D. Cornell University), Henry Platt Bristol Professor of International Affairs at Hamilton College, has published on many aspects of European politics, specializing particularly in EU external policies. Dr. Cafruny has published several books, including *The Union and the World: The Political Economy of a Common European Foreign Policy*, (Kluwer Law International 1998), *Ruling the Waves: The Political Economy of International Shipping* (1987); *The State of the European Community: The Maastricht De-*

bates and Beyond (1993, with Glenda Rosenthal); Europe's Ambiguous Unity: Conflict and Cooperation in the Post-Maastricht Era (1997, with Carl Lankowski); *The Political Economy of* European Foreign Policy (1998 with Patrick Peters); and Europe's Ruined Fortress: Neoliberal Hegemony and Transformation in Europe (2003 with Magnus Ryner).

Michele Chang (Ph.D. University of California, San Diego), Assistant Professor of Political Science at Colgate University, specializes in European Economic and Monetary Union and is the author of *Realigning Interests: Crisis and Credibility in European Monetary Integration* (New York: Palgrave, 2004.



John Occhipinti (Ph.D. University of Maryland), Associate Professor of Political Science at Canisius College, specializes in EU justice and internal security policies. Dr. Occhipinti is the author of *The Politics of EU Police Cooperation: Toward a European FBI?* Lynne Rienner Publishers, 2003

Henry Steck (Ph.D. Cornell University), State University of New York Distinguished Service Professor and Professor of Political Science, SUNY Cortland. Dr. Steck is SUNY Cortland's Director of the James M. Clark Center for International Education and Director of Cortland's Project on Eastern and Central Europe. He is on the Board of Directors of the Alliance of Universities for Democracy, has published articles on higher education, and has held a Fulbright Study Travel Grant as well as several other grants for work in Serbia and Central Europe.

THE DEBATE - ARE EUROPE AND THE US DRIFTING APART

Thursday, June 30th, 12:00 - 2:30

There has been extensive discussion and analysis in recent years as to whether the relations between Europe and the US have been undergoing a fundamental change. With the Cold War over and with no 'common enemy' to hold Europe and the US together, a number of significant clashes have occurred between 'the partners': over, for example, trade issues, over the Kyoto Protocol on international environmental protection, and over Iraq.

This debate will air some of the key issues shaping European-US relations and will examine the extent to which the nature of the transatlantic relationship is being transformed.

The debate will be led by a European and American: Professor Neill Nugent, Professor of Politics and Jean Monnet Professor of European Integration at Manchester Metropolitan University, UK, and Professor Alan Cafruny, Henry Platt Bristol Professor of International Affairs, Hamilton College.

The two speakers will debate for about thirty minutes and then the debate will be open to the floor (lunch is included).

THE SIMULATION

An interesting and stimulating way of furthering knowledge and understanding of 'how the world works' is to simulate real-life situations. This simulation will focus on two key aspects of the European Union: how it operates when its 25 heads of government meet – in a body that is formally known as the European Council; and what issues it has to consider when it is formulating its relations with the US.

- * Tuesday June 28: 4pm-5.30pm: Country Teams Decide their Negotiating Positions for the European Council meeting
- * Thursday June 30: 4pm-5.30pm: European Council meeting tries to reach a consensual EU position for the negotiations with the US
- * Friday July 1: 1.30pm-4.45pm: Conclusion of Simulation
