#### **Global Classroom**

The General Secretariat conducts a vote on the alternative agenda items the delegates wish to discuss should their committee achieve consensus on their assigned agenda item on or before the Saturday morning session.

# **PROGRAM NOTES**

#### **Keynote Speaker**

#### His Excellency Ambassador Olof Skoog

Ambassador Skoog was most recently the Permanent Representative of Sweden to the United Nations, and in this capacity served as the Chairman of the United Nations Peacebuilding Commission and President of the UN Security Council. He has previously been Director-General for Political Affairs in the Swedish Ministry of Foreign Affairs and has represented Sweden at the European Union and at the Organisation for Security and Cooperation in Europe (OSCE). He has also been Swedish Ambassador to Colombia, Venezuela, Ecuador and Panama and served as Executive Assistant to Dr. Hans Blix in the UN verification of WMD in Iraq. With the European Union, Ambassador Skoog served as the first Permanent Chair of the EU Political and Security Committee, coordinating the EU Common Foreign and Security Policy. He was then posted as the EU Ambassador to Indonesia and Brunei, also representing the EU to ASEAN. Ambassador Skoog was born in 1962. He is married to Johanna Brismar, currently Sweden's Ambassador to Brazil. They have three children.

#### **Expert Witness Panel**

#### Mr. Joseph Dunne

Mr. Joseph Dunne is Director of the European Parliament Liaison Office in Washington DC, which was set up to foster and develop relations between the European Parliament (EP) and the United States Congress, from October 1, 2019. In 2018, Mr. Dunne was a Senior Resident Fellow at the German Marshall Fund in Washington DC and a Visiting Fellow at the Schar School of Policy and Government at George Mason University. Up to that time, Mr. Dunne was a Director in the Directorate General for European Parliamentary Research Service. He was previously Head of Secretariat for the Internal Market and Consumer Protection Committee and Deputy Chef de Cabinet for EP President Pat Cox. Before the Parliament, Mr. Dunne served in the Irish Department of Foreign Affairs. He edited the first edition of 'Mapping the Cost of Non-Europe' in April 2014. Mr. Dunne has a B. Mod from Trinity College Dublin and an MA in EU Law from King's College London.

#### Dr. Natalia Cugleşan

Dr. Cugelşan is Lector at Universitatea Babeş-Bolyai Cluj-Napoca, Facultatea de Istorie si Filosofie, Cluj-Napoca România. Dr. Cugelşan directs the Jean Monnet Module, Digital teaching and Learning in the Field of EU Integration Studies in the New Member States (2020-23). She has directed Jean Monnet Modules in Multi-level Governance, has been awarded a Jean Monnet Chair in Governance and Community Policies, and has served on multinational projects such as the Atlantis Mobility Project in Transatlantic Public Administration (co-funded by the European Union and the US Department of Education). She has also served on national projects, including "Multi-level Governance in Romania" and "Romania and the Future of Europe." Dr. Cugelşan research focuses on post-accession compliance and capacity building and transatlantic relations, including as co-editor of *The New Transatlantic Relationship: Politics and Policy Perspectives* (Routledge 2015).

#### **Dr.** Carolyn Dudek

Carolyn M. Dudek, Ph.D. is Professor and Chair of the Department of Political Science and Director of European Studies at Hofstra University. She specializes in comparative politics with regional focuses in Europe and Latin America. She is the author of *EU Accession and Spanish Regional Development: winners and losers*. In addition, she has published several articles and book chapters on trans-Atlantic agricultural trade and regulatory disparities, Spanish politics, regional nationalism in Europe, European Union regional development policy, EU-Latin American relations, the immigration crisis in Europe and the rise of the far right. She is also a regular editorial contributor to *La Razón*, a national newspaper in Spain. Her current research focuses on the EU's policy to combat antisemitism. Professor Dudek has been awarded a Fulbright Scholarship to Spain and Argentina and was a Jean Monnet Fellow at the European University Institute in Florence, Italy. In spring of 2021, Professor Dudek was named Mentor of the Year at Hofstra University. She is currently the coordinator for the ERASMUS+ Jean Monnet Module at Hofstra University, which is focused on EU Anti-Discrimination and Hate Crime Policy.

#### Dr. Nikolaos Zahariadis

Nikolaos Zahariadis is the Mertie Buckman Chair and Professor of International Studies at Rhodes College in Memphis, TN, USA. He researches comparative policymaking at the intersection of domestic and international affairs with substantive emphasis on European political economy. A native of Greece, he has scored a Fulbright hat trick – awards in Germany, Greece, and Italy respectively – and has been a Policy Studies Organization Fellow, National Bank of Greece Senior Research Fellow, Economic and Social Research Council (UK) - Social Science Research Council (USA) Fellow, adjunct scholar at the Woodrow Wilson International Center for Scholars, visiting professor at Sciences-Po Grenoble, as well as chair of the public policy interest section of the European Union Studies Association, and thrice-President of the International Studies Association-South. He hates Covid-19 and loves travelling and tasting new foods in small and unassuming restaurants.
